UPON THE HEARING OF THE FIXED DATE CLAIM FORM filed by the Director of Public Prosecutions and dated 5<sup>th</sup> April, 2022 and coming up for hearing this day and upon hearing *Shawna Kaye James* Counsel for the Applicant, as instructed by the Office of the Director of Public Prosecutions.

**IT IS HEREBY ORDERED THAT:**

1. In accordance with section 14 (10) (a) of the Terrorism Prevention Act, **QDe.161 Name: ISLAMIC STATE IN IRAQ AND THE LEVANT - KHORASAN (ISIL- K)** designated as terrorist entities by the United Nations Security Council and whose information were amended to the United Nations Sanctions List under Reference Number SCA 2/22 (08) dated April 1, 2022 are hereby declared as listed entities for the purposes of the Terrorism Prevention Act:

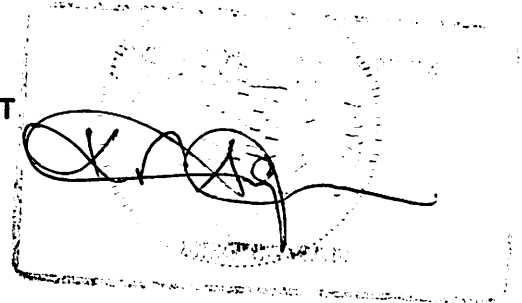
AND

2. In accordance with section 6 (1) of the **Terrorism Prevention Act**, no person in Jamaica or no Jamaican in or outside of Jamaica shall knowingly:
  - a. deal directly or indirectly with any property that is owned or controlled by or on behalf of the above listed entity.
  - b. enter into or facilitate, directly or indirectly, any transactions in respect of that property that is owned or controlled by on behalf of the above-mentioned listed entity

- c. provide any financial or related services in respect of that property that is owned or controlled by or on behalf of the above-mentioned listed entity.
  - d. Convert any property owned or controlled by or on behalf of the below mentioned entities or take any steps to conceal or disguise that property is owned or controlled by or on behalf of the above-mentioned listed entity.
3. This Order relates to 2022: QDe.161 Name: ISLAMIC STATE IN IRAQ AND THE LEVANT - KHORASAN (ISIL- K) whose details are contained in UN document SCA/2/22 (08) dated April 1, 2022 and remain in effect except or until an Order is made by the Court for any exemption in accordance to section 14 (B) or 14(C) of the Terrorism Prevention Act or otherwise revoked or modified.
4. The Applicant's attorney is to prepare, file and serve a copy of this Order along with a copy of UN document SCA/2/22 (08) dated April 1, 2022, issued by the United Nations Security Council Sanctions List Committee on all relevant authority and financial institutions.
