4. The Applicant's attorney is to prepare, file and serve a copy of this Order along with a copy of UN document SCA/2/22 (03) dated 24<sup>th</sup> January, 2022, issued by the United Nations Security Council Sanctions List Committee on all relevant authority and financial institutions.
